### [FLSO Adds New Data Fields To SLIP](#)

The FLSO has added several new Mandatory fields to the Insurer SLIP system. They are now requiring the Insured's State of Domicile, Florida Allocated Premium and Total Allocated premium. Looks like they are trying to get ahead of any NRRRA changes that may come up.

The MA Dept of Insurance has advised that although the issue of fees is not specifically addressed by regulation, it is the Departments position that generally fees are not allowed. The only fee that may be acceptable would be for a bona fide service like the cost of an inspection if required.
