[SLSOT Bulletin #SO-2011-11 Guidelines for Texas Surplus Lines Agents](#)

Tax 100% of the premium if TX is the home state. Stamping fee applies to 100% of the premium.

When reporting multi-state and/or exempt premium policies and filing by paper, you must complete this **new form** which replaces the previous OTHER STATES/EXEMPT PREMIUM form. Instructions are included on the examples for policies effective both on and after 07/21/11 and prior to 07/21/11.

Clarifies that Homeowners coverage can be placed in the Surplus lines market. An individual producer, after having performed a diligent search for coverage among licensed carriers as required by W.Va. CSR § 114-20-4, may place the coverage through a surplus lines licensee, without having first attempted to place the coverage with the West Virginia FAIR Plan.

With the passing of HB6652 on 6/22 the NRRRA revisions are now in place. This includes a change in the reporting period to 45 days from the end of the quarter. CT will tax on 100% of Gross Premium

if CT is the Home state. Multi state premiums are to be allocated and charged at each states rate
